ON Congress cuts two gaming board members during board confirmations

April 7 secret ballot votes on board confirmations rescinded, redone publicly April 15

Osage News finalizes rules for candidate debates May 8 and 9

League of Women Voters of Tulsa to help with debates; debates to be broadcast live on Nation's Web site

The Osage News has finalized the rules for its inaugural candidate debates May 8 and 9.

The debates, which will split 18 congressional candidates into three groups of six by alphabetical order of their last name, will be held at the Wah Zha Zhi Cultural Center and will be broadcast live on the Nation's Web site at osagetribe.com.

The first day of the debate, May 8, will feature the five chief candidates, the six candidates running for assistant chief and six congressional candidates. The second day, May 9, will feature two groups of congressional candidates.

The rules

Each group of candidates will be asked a total of three questions. Each candidate will draw a number to determine in which order they are to answer. The candidates will draw numbers before each question to ensure that each candidate has a chance to answer first or answer last.

Candidates will have three minutes to answer a question and one minute for rebuttal. A representative from the League of Women Voters of Tulsa will time the candidates' responses, give a 30-second warning and announce when their time has expired.

The *Osage News* will publish a program for each day of the debate, outlining the rules for the debate and also publishing the questions that are to be asked for each group. Each group to debate will have the questions for the same amount of time and the audience will be able to follow the debate.

Questions will not be allowed from the audience, applause or any type of demonstration will not be allowed while the candidates are debating. The Osage Nation Police Department will be on hand. No visual aids, such as power points, may be used by a candidate.

Twenty-five Osage candidates speak at Revard political rally in Edmond

Candidates for the executive and legislative branches, Minerals Council discuss why they should be elected

EDMOND, Okla. – Twenty-five Osages running for office in the June 7 election addressed a standing-room-only crowd here at the VFW Hall during a March 16 political rally hosted by the Revard family.

The candidates for the Nation's executive and legislative branches and the Minerals Council asked the crowd for their votes during the candidates' individual speeches which touched on several topics including their political platforms, their family relations, concerns about the current government body, prior work experience, and humor.

The Osage News attended the rally which had more than 60 people which included candidates, their family members and fellow tribal members in attendance. Here is a sampling of what some of the candidates shared with the public.

Revard family member Jim Ryan, who helped arrange the rally, asked the candidates to draw numbers written on paper from a hat to determine the order of speakers.

Congressman William "Kugee" Supernaw, who is seeking a second term, drew No. 1 and advised the crowd they should "do the best job they can" and "call back home" to study the candidates. He said can-

didates should have three things: "integrity, intelligence and energy."

"During this campaign, all you're going to know about us is what we tell you," he said. "I would suggest that you take the time to find out more about people, about their performance in the past, and study as much as you can."

Charles Pratt, who is a plaintiff in the Fletcher v. United States case concerning non-Osage shareholders, is running for the Osage Minerals Council. Pratt and four other plaintiffs in the case are seeking an accounting and restoration of trust shares from non-Osages.

"We've been up and down, back and forth, but on Minerals (Council), we're going to have to have someone that is prepared to deal with the return of those shares we are able to get back through the Fletcher case," Pratt said. "Contact me if you want to know more about Fletcher," he said of the lawsuit.

Curtis Bear, who is running for the Minerals Council, said he has been attending council meetings for several years and the knowledge he gained will help him serve, if elected. "The Minerals Estate and the shareholders must be protected in this time of economic uncertainty."

"The Osage Nation is currently facing major lawsuits and some unnecessary lawsuits. I believe that you must vote for leaders that have a foresight not only in the future, but now in our travesty of time,"

ON Congressman Doug Revard pulls out of election race; ON Election Board doesn't certify Louis Gray's candidacy for Osage Nation Congress

Osage Nation Congressman Doug Revard, who was seeking reelection in June, has bowed out of the race due to family reasons.

"I am going to withdraw from the election," Revard said in a phone interview Friday. "It's for family reasons."

Louis Gray appealing Election Board's noncertification of candidacy

The election board did not approve Louis Gray's candidacy because he told them that he had been charged with a felony in 1992. Gray was not convicted of the felony and the incident does not appear on Gray's record. The election board would never have known about the charge except for Gray told them about it.

"I didn't want to play legal parlor games, I was just trying to be honest," Gray said.

The election board will be holding a hearing April 22 at their regularly scheduled meeting during an Executive Session and will have 10 days to issue the ruling.

"I feel really great about it, the whole thing comes down to one question: 'Am I a convicted felon?" Gray said in a phone interview April 17. "I got it in black and white, I got it from the judge himself. I was charged and not convicted. Under the constitution, under their own law, you can't have been convicted of a felony, and I was never convicted."

The violation in question is a 1992 Bogus Check by Gray. He was charged with the felony after a publication he was running, the Osage Countian, went out of business and he paid the last bill with a bogus check. The bank had already closed the publication's account and he was unaware of the violation, he said. The court made Gray plead guilty but eventually dismissed the charge.

Osages seeking office who have been convicted of a felony, whether it was expunged or committed as a juvenile, cannot run for office according to the Osage Constitution and the new election law.

Gray has passed many strenuous background checks since the violation. In 2006 he ran in the Osage elections for a four-year congressional term, he's passed background checks by the Federal Bureau of Investigation, the Secret Service, the White House and has also covered as a journalist the 2008 Democratic National Convention in Denver, he said.

Gray announced on his Facebook page that he appealed the decision and many comments were posted underneath the thread expressing encouragement for his campaign.

"We just want to move forward and get this election going and move on," Gray said. "I'm not mad at anybody."

Because the *Osage News* is non-partisan and does not support or oppose individual candidates, all political advertising (including brochures, bumper stickers, signs, buttons) is prohibited at the debate.

The questions

A question committee will be formed and be comprised of seven people. The three staff members of the *Osage News* and four members of the public. Each member of the question committee will be asked to sign a confidentiality agreement.

The questions will be formed from the following topics: Economy, health, education, social services, gaming, legal, energy, preservation, culture and natural resources.

The moderator for the debate, Bryan Pollard, editor of the award-winning *Cherokee Phoenix*, the tribal newspaper of the Cherokee Nation, will be in charge of asking the questions and moving the debate along. He will also enforce the ground rules of the debate and ensure that each candidate has an equal chance to answer the question. earlier this month then voted again — in the open — on all board appointees which resulted in dismissals of George Pease and Elizabeth Lohah Homer from the Gaming Enterprise Board.

The April 15 votes came eight days after the Congress declined to confirm board members Frank Oberly, Pease and Chairwoman Homer in a secret ballot vote on April 7, which left the Nation without a gaming board to oversee the Osage Million Dollar Elm Casino's multi-million dollar operations for the seven-casino venture.

All three public April 15 gaming board confirmation votes ended with 6-6 tie votes, which left the tie-breaking vote up to Assistant Chief John Red Eagle.

On April 9, Principal Chief Jim Gray resubmitted all three gaming board members to Congress as appointees for confirmation and followed up with an executive message on April 12 stating: "The Osage Nation Congress failed to follow the rule of law when they voted by secret ballot on April 7, 2010" and advised them of potential impacts to the Nation's gaming operations if the gaming board remains vacant.

In his April 12 letter, Gray said "the Osage Nation Constitution and Osage law mandate that voting be conducted openly and made public by record" before listing potential consequences of not having a gaming board in charge of several duties including managing the casino's finances; authorizing the distributions of gaming revenue to the Nation; and signing payroll checks for the casino employees.

"If there is to be a distribution of gaming revenue to the Osage Nation, that has to be authorized and the check has to be signed by the board... so even something as basic as giving the Nation its gaming revenue is now a question... There's just lots and lots of implications here that are very troubling,"

Homer told the Osage News in a phone interview after Congress failed to confirm her to the gaming board on April 7.

The Congress met with legal counsel in executive session April 14 but took no action on Gray's letter after the meeting which lasted more than an hour. All 12 Congress members reconvened the next day and acted on motions to vote again on confirmations for the Nation's Gaming Enterprise, Health and Wellness Advisory Board, Editorial Board, Limited Liability Company Board and alternates for the Election Board.

Motions to vote again

Congressman Eddy Red Eagle made a motion "to ratify all appointment confirmation votes that were taken during this Hun-Kah Session" on April 7 and April 9. His motion passed with a 7-5 vote with "no" votes from Congressmen Mark Freeman, Raymond Red Corn and Congresswomen Shannon Edwards, Debra Atterberry and Faren Revard Anderson.

Red Corn then made a motion to "rescind all appointment confirmation votes" from April 7 and April 9 and "to expunge those votes from the record." His motion passed unanimously, which lead to individual confirmation votes of all the appointees with the gaming board votes generating the most discussion.

"We all know, and whether we want to face the fact or not, we have had an accounting problem ever since we've been here. That accounting problem has got somewhat better in probably the last six months... We have been given information that was not always correct and a lot relied on that information," Congressman Doug Revard said in his list of concerns about the current board.

"When this Congress passed the gaming law that is in place now, I believe that Congress made a mistake and the mistake was having all three board members serve contemporaneously with each other so that when their term of office is up, all three board members are either reconfirmed or they're let go," Congresswoman Edwards said. She encouraged the other Congress members to keep at least a majority of the board, adding she's reviewed gaming board reports and "numbers don't lie, the gaming enterprise is doing well. Therefore I think it's critical that we not make wholesale changes at this time."

The motion to confirm Pease failed with a 6-7 vote. Voting "yes" were Edwards, Freeman, Atterberry, Red Corn, Anthony Shackelford and Archie Mason. The "no" votes came from Mark Simms, William "Kugee" Supernaw, Faren Revard Anderson, Jerri Jean Branstetter, Red Eagle, Revard and Assistant Chief John Red Eagle.

After Pease's dismissal, Edwards addressed the Congress before they voted on Oberly. "He is now a practicing (certified public accountant). He has had many, many experiences with audits." She also noted Oberly served on the board when the seven-casino venture received "an unqualified audit" during its last audit which is "very important to our gaming operations."

Congress voted the same as they did with Pease, but Oberly's confirmation passed with Assistant Chief Red Eagle's tie-breaking "yes" vote, making it a 7-6 vote.

When Homer's confirmation vote came up, Atterberry said "we all had an opportunity to look at the resume that was sent to us by Elizabeth Homer, we also know the work she's done in the gaming area and we have a very qualified Osage willing to put forth her time and effort for the betterment of this Nation."

Homer is a Washington, D.C.based attorney and founding partner in Homer Law Chartered which focuses on cases concerning Native American issues. She served as vice chairwoman from 1999 to 2002 on the National Indian Gaming Commission, which regulates gaming activities on Indian lands to protect gaming tribes from organized crime or corrupting

influences and she's also served as attorney for the Gaming Enterprise Board before Gray appointed har last Nevember

her last November.

Congressman Red Eagle said Homer "has tremendous skills, I'll grant that, and those skills lay in another area. She's not had that frontline experience of dealing with 1,000, 2,000 people and all the intricacies of the demands of the marketing concept... She does have other skills that can be of tremendous aide to this Nation."

Red Corn responded to Revard's comments about the accounting problems and noted they improved during the time Homer was on the board. "Seeing her resume, it's very difficult for me to see that we could find anybody more qualified than Ms. Homer."

Edwards referred Congress to a publication on gaming, which Homer contributed to. "Recently a book was published called Sovereign: An Oral History of Indian Gaming in America. She was included as an authority in this book on Indian gaming because she is an authority of Indian gaming... Ms. Homer knows her stuff," Edwards said.

The vote on Homer's confirmation repeated with the same pattern as Pease's in which Congress voted 6-6 with Assistant Chief Red Eagle breaking the tie with a "no" vote.

Votingosage.org poll a big hit with Osages

Online poll on votingosage.org cannot track whether votes are cast by Osages

Osage Nation Principal Chief Jim Gray and Tim Tall Chief were neck and neck in the principal chief votingosage.org candidate poll, where Tall Chief was leading Gray with 19 votes as of 10 a.m. April 6.

The poll generated traffic for the site, which was formed by a group of young Osages, and is so popular that nearly 1,000 people voted in the poll the week of March 30 – a little less than half of the number of Osages that voted in the 2006 election. Once Osages voted, many were also commenting on the various topics the site offers. Candidates can also be found commenting regularly on the site as well.

"My hope for this poll was simply meant to stir interest in this election," Ryan Red Corn said, administrator for the site and Osage tribal member. "I don't think it will so much change the minds of voters as it will affect the behavior of the candidates."

And it already has. Once news of the poll got out, Tall Chief sent e-mails to friends asking them to vote on the poll and also noted that people didn't have to be Osage. Gray posted to his Facebook status for his friends to vote on the poll, causing his numbers to jump in a

single day, while the other candidates dropped in the rankings.

"I'm having fun with it, these online polls are designed for entertainment purposes only," Gray said. "What I am excited about is that it gets people talking about the issues that are affecting the Nation and it's good to see Osages getting involved with the election...the only vote that matters is the vote that happens on June 7."

Leading the poll April 6 was Tim Tall Chief with 474 votes, in second was Jim Gray with 455 votes, third place was John Red Eagle with 44 votes, fourth place was Chico Sellers with eight votes and in last was Roy St. John with five votes.

Online polls are not to be compared with a Gallup Poll, where a random sample of the population is selected to represent the entire population. Online polls are viewed as biased because a person taking the time out to participate in an online poll more than likely has a vested interest in the issue and is not a true representation of the population, according to gallup.com.

"Of course, we have no way of verifying whether or not a voter is Osage, so these poll results should not be viewed as scientific," Red Corn said. "As for telling non-Osages to go vote, I regard that behavior as disingenuous to the validity of the office those individuals are seeking."

Assistant Principal Chief John Red Eagle, who is also running for principal chief, said "I do have to work you know, I can't get on Facebook all the time and tell everyone to vote."

"I looked at it when it first came

out and I knew [Jim Gray and Tim Tall Chief] had got on Facebook and was telling all their friends to vote for them," Red Eagle said. "I knew that it was probably inaccurate, not because I'm in third place, but because you don't have to be Osage to vote."

St. John has no plans to campaign for people to vote for him on the poll, he said.

"I think it's an attempt to sway votes and I have no idea how accurate it is," St. John said. "I don't know if there's anything you can do about it. If people are swayed by an election poll of this nature, and I assume some are, there's nothing I can do about it."

"I don't know who votes on it or that it has any accuracy, I don't believe it's an accurate poll and I question its validity," St. John said. Carl "Chico" Sellers echoed St. John's comments. "The web site is supposed to help inform all Osages regardless of their residence," he said. "How does an unscientific, unregistered poll inform out-of-state Osages about candidates?"

The poll was for the principal chief race the week of March 30 but Red Corn cycles the polls out every Wednesday. So one week will be Assistant Chief, next will be legislative and so on. Osage Minerals Council candidates will not be included in the poll.

"I think the site has been great at generating ideas, which has been its intent from the get go," Red Corn said. "We are hoping that those ideas emerging from the discourse could be considered by our elected officials."

Tim Tall Chief did not respond for comment on this article.

informed the Legislative Branch that voting by secret ballot could be a violation of the Nation's Open Meetings Act (ONCA 07-53).

A section of the bill calls for the public body holding a meeting to record minutes which must include: "A record or summary of all motions, proposals, resolutions or other matter formally voted upon, the results of the vote and the vote of each member of the body."

Hepsi Barnett, the Executive Branch's Chief of Staff, told the Osage News that attorneys for the chief's office found the law violations after the April 7 secret ballot votes and sent the Congress open records requests asking for the voting records of that day's session.

Reached by phone after the April 15 session, Homer said she was "disappointed with the final outcome" but was pleased with the confirmation votes made publicly.

"I'm really glad it was a vote that was taken in the sunshine... I would have been happier if the vote had gone my way and I'm obviously disappointed," she said. "I think that was a really important precedent to establish and a really important commitment for the Congress to make – that is what accountability in government is all about."

"I am really glad they kept Frank Oberly," Homer said, adding there are still concerns about having only one gaming board member to handle the board business alone because it's not possible to have a quorum. "But I think it's going to be a whole lot easier to get one appointee instead of three appointees."

In response to some Congress members' concerns about the board's performance, Homer believes "the board has done a good job. I think any objective view of what the board has managed to accomplish in the last year is favorable."

"We have a profitable gaming

operation in a declining economy," said Homer adding the gaming board has made monthly distributions to the Nation of \$2.5 million since she was appointed to the board by Chief Gray in November 2009. "You can't argue with success."

April 7 session much quieter than the April 15 session

On April 7, the 11 Congress members present issued their votes in writing after Simms motioned for the Congress to vote on the three Gaming Enterprise Board confirmations and one for the Osage Limited Liability Company Board one-by-one by secret ballot.

"Why secret ballot?" Atterberry asked after Simms made the motion. "We've always done it that way," Simms replied. Atterberry asks "why?" again before saying "I'd rather not." No one responded to Atterberry.

Voting "yes" to hold the secret ballot confirmations were Congresspersons Red Eagle, Revard, Shackelford, Simms, Supernaw, Anderson and Branstetter.

Corn and Mason voted "no" with Atterberry to voting in secret with one absence from Edwards.

That day, Congress decided against Homer's confirmation with a 5-6 secret ballot vote; Pease, 4-7; and Oberly, 5-6. LLC Board member Paul Bruce was confirmed with a 9-2 vote.

Reached by phone after the April 7 secret ballot votes, Supernaw said "I'm in agreement with what happened" and referred to prior problems concerning the casinos and board decisions, some of which he said he can't disclose due to proprietary issues. He referred to prior issues which include an ongoing Osage County District Court case involving former Chief Financial Officer Bill Leonhart who is suing Gray, Pease, Oberly and former gaming board chairman Tom Sla-

mans for breach of contract after he was fired in August 2009 before his contract expired.

"Here is the problem: if you look back over the history of our gaming operations, all the problems you hear about... they were decisions made by the gaming board," Supernaw said. "My hope is we get a board in there that is mature enough and strong enough that they don't really interfere too much with the operations of the business."

Amid prior problems, the Gaming Enterprise Board worked to upgrade its accounting operations, Homer said. "We made the necessary investment in technology and we now have a state-of-the-art casino accounting system," she said adding the casino enterprise was given an outstanding report after an independent audit was conducted of its 2009 operations.

The casino entity's fiscal year 2009 financial statements were examined by a New Mexico-based independent firm and it issued an "unqualified opinion," which "means is that we have a good, reliable beginning balance for FY 2009," Homer told the Osage News in December.

Chief Gray called the April 7 secret ballot decisions "unfortunate" and "reckless because the impact of not having board members affects decisions" to be made and he criticized the Congress's move to hold such votes. "The practice of voting secretly is totally against accountability and transparency," he said in a phone interview after the votes.

Gray questions whether votes are revenge

Chief Gray made no attempt to mask his opinion in what he thought was behind the majority's vote to decline confirmation of Homer hours after the April 7 secret votes.

He mentioned "2008" when

four members of Congress allegedly entered restricted areas of the Hominy casino, which prompted an investigation by the Gaming Commission as requested by then-Gaming Enterprise Board Chairman Tom Slamans. "They've never

really forgiven them for that," Gray

said.

The Hominy incident that Gray is referring to is when Supernaw, Revard, Shackelford and Branstetter requested to see documents in a restricted area of the OMDE Hominy casino on July 23, 2008 when they had no authority to do so, according to an article by The Bigheart Times.

According to the Gaming Commission report, the four members of Congress asked Hominy casino staff to open boxes and see auditing records for the Bartlesville casino in a restricted area meant only for licensed staff. The staff was then questioned as to the practices of the auditing process.

The four Congress members were called to a hearing that was presided over by Homer and Gaming Commissioner Richard Chissoe. This is why Gray thinks those four members of Congress voted secret ballot to decline her nomination.

Regarding the Hominy casino visit, Supernaw wrote in his Jan. 31 newsletter: "...members of Congress exercised their oversight responsibility and investigated the reports of accounting irregularities... only to be investigated ourselves, blasted in the Osage News and for a time even questioned by others members of Congress."

Chissoe resigns as ON Gaming Commissioner

Richard Chissoe, who has served as the ON's gaming commissioner for the past four years said he will not be seeking, nor will he accept, confirmation to serve a second

And finally Osage Nation legislators must demonstrate the judgment and discipline to focus on drafting and passing good legislation.

have been aware of and/or engaged with legislative decisionmaking bodies. I have worked with boards of directors, tribal councils, city councils, state legislatures, the U.S. Congress, and Osage Nation Congress. And although this is my first experience running for an elected office,

my experience interacting with legislators from an executive point of view will allow me to serve as a valuable asset to our Congress in bridging the gap in accommodating multiple perspectives and adopting good law.

Commitment

I am committed to the better-

professional career I ment of the Osage Nation, and enriching the lives of Osage people. I have worked across the country for the betterment of Indian country, tribal organizations, and tribes, and during that time have always shared good ideas and opportunities with Osages and Osage programs back home. I was honored to join the Administration of Principal Chief Jim Gray, an honor I accepted gladly although I did not know what that commitment would truly entail. 
Joe 'Sonny' Abbott announces candidacy for Minerals Council

My only promise is to honestly represent and protect our Osage Minerals Trust as much as the present Osage Nation Constitution will allow. This is a very critical concern of mine and should be of all Osage Shareholders.

I am not a politician! We all know that politicians say and promise what they think you want to hear. We have witnessed this in the

Bear said. "Our Minerals Estate has brought us into the future and it will take us forth into more prosperous years ahead."

Jeff Irons, who is Federal grants program manager in the Nation's Strategic Planning and Grants Management Office, is running for assistant principal chief.

"As your assistant principal chief, I will try to work with whoever's in office to take legislation to the Congress, encourage them to support the recommendations of the legislation of the chief," Irons said. "That being said, if Congress has legislation they want passed and want the chief's support, I will feel obligated in part to go to him and encourage support there."

Also running for assistant principal chief is former Oklahoma State Representative Scott BigHorse. "I think I'm the only candidate... that has any experience in a three-branch government that has been in operation for over 100 years, so I do have some expertise in developing policy," he said, adding he's worked with both state and national legislators.

"As assistant chief, I think one of the biggest things I'd like to see is the transparency issue. To me, transparency is showing every bit of revenue that is made by the tribe, excluding the minerals," Big-Horse said. "I would like to see a flow chart with the reasons why all that money came into the tribe... I'd also like to see a flow chart of all the monies that leave the tribe and where it goes and why."

John Red Eagle, who is a critic of Principal Chief Jim Gray's administration, is running for principal chief and shared his concerns about the current government. "I am presently serving as your assistant principal chief and as the stepchild of the Executive Branch – that was a joke, people," he told the crowd which laughed.

"With the money that comes in, I think we have to have a real accounting...I want to know how much this (Osage Limited Liability Company) makes, what types of investments are they making? You need to know that because it's your money," Red Eagle said. "There needs to be a quarterly report of all the revenue that comes in, whether it's through the casino, investments."

Retired nurse Cecelia Tallchief is running for the assistant principal chief's office, which she describes as an "important" one as a "mediator; "You have to be able to look at what's best for the Osage people, not what's best for Congress, not what's best for the Executive Branch, what's best for all."

Tallchief said her experience, which includes serving on the Osage Home Health Board, and working as an Indian Health Service nurse makes her the best candidate for the job. "When (the Home Health Board) took the program over, it had been running in the red. We – with our expertise – have been able to turn that around and for the past two years have not asked for any money from Congress."

James Schooling, who is running for the Minerals Council, said he has "worked in the oil and gas business for 40 years in various areas. I think you have to work with other branches of the government," he said adding he's learned to work with other people in prior employment.

"I see a lot of in-fighting and that's got to stop. I think you got to get out there and do everything you can to make it work," Schooling said. "When I'm elected, I want you to contact me anytime you've got a problem ... I'm for honesty, integrity and transparency."

Congressional candidate Jake Heflin, a Long Beach, Calif. paramedic/ firefighter, said it's important to revisit the Nation's 25-year strategic plan which sought input from Osages living outside Oklahoma to "enable that to occur." As part of improving the Nation, Heflin said he believes health and senior services should improve.

"The reality is we do have the resources now to do that," Heflin said. "There's no reason why we shouldn't have assisted-living facilities on our reservation for our elders... we've always been taught that we need to take care of our youth and we need to take care of our elders. Well we need to start doing that right now."

Galen Crum, who is president of the Osage Shareholders Association, recently retired from working with the fire service and is now seeking a Minerals Council seat. "I think fire service is a great place to be... you get instant gratification from it," he said, describing a firefighter's role as turning "chaos into order and you get to meet people or help people that are having the worst day of possibly their life."

"That's kind of what I want to do for the Minerals Council," Crum, a 2006 Congressional candidate, said of extending his public service experience. "I think the Minerals Council need to work with the tribe."

Congressional candidate Margo Gray-Proctor, current principal chief Jim Gray's older sister, is president of Horizon Engineering in Tulsa and said she's worked with on over 150 tribal projects nationwide. "I've also been able to share in the resources and have the opportunity to improve Indian Country and that's what made me come here today."

Gray-Proctor also worked for the former Osage National Council in writing legislation and said she brings an expertise in economic development in serving on Congress. "We want to create economic development for our own people," she said of creating more job opportunities for tribal members.

Minerals Council candidate James Revard said his oil and gas industry experience makes him the best candidate to serve. He is executive director of the Commission on Marginally Producing Oil and Gas Wells for the state of Oklahoma

"My job at the state agency is to protect oil and gas, to keep oil production running as long as we can... I strongly believe we can do the same thing for the Osage (tribe)," he said. "The key is more drilling, optimize the wells we have and to work together."

Osage Nation Principal Chief Jim Gray is seeking his third consecutive term and said "elections are primarily about the future — they're about 'where do you want to be four years from now?' — And I think that's one of the reasons I've decided to run again."

"In some cases, we've been defined by our differences, but in many ways we've been defined by our successes," Gray said of the relationship between the executive and legislative branches. "In 2002, we had about \$300,000 in tax revenue in the bank, we had about 200 employees. Today we employ about 1,700 people, we have \$50-\$60 million in the bank - depending on which number you want to go by: the end of 2009 or where we are today," he said.

Attorney Geoffrey Standing Bear, who is seeking a Congressional seat, said "we really have to work together because the last four years have brought out some of the worst in us." He said the need to work together will come into play if the Nation's casinos are affected by the recent 10th Circuit Court decision.

Standing Bear previously served as assistant principal chief in the early 1990s and has practiced law for entities including the Oklahoma Indian Gaming Association. "We've got to find ways to diversify

Fellow Osages: I'm a Candidate for the Mineral Council. I've been an Annuitant for 25yrs. My father was Charles Crum, his mother Anna V. Boulanger Crum and her father Joseph Boulanger, were original allotees. Grandpa Joe is pictured at the Tribal Museum with the 1895 Tribal Council.

I was born on Anna's allotment south of Elgin, Ks, and raised in the Elgin/Sedan Ks. area. After graduating from Sedan High School I attended College in Arkansas City.

As a Council member I hope to enhance mineral income, specifically by ensuring we are paid properly for production. We need to bring monitoring of oil tanker access, and the measuring and metering of mineral production into the 21st century. A problem with the natural gas metering system has been identified that suggests we are being underpaid by 10% or more on gas production.

Politically, my goal as a Council member will be to return Mineral Trust control to the Annuitants. The Mineral Council, as the body elected by Osage shareholders to conduct Trust business, should do so without interference from the Chief or Congress.

When the Osage people started the process of forming a more inclusive government, an extraordinary thing occurred. A group that enjoyed complete control of their government sought to delegate much of that power to others. These Osage Annuitants willingly started a process that would render themselves minority voters. They only asked for one thing in return, that the Mineral Trust be left in their control, to be governed by representatives elected solely by them as it always had. Sadly, the Osage Constitution didn't deliver on this simple agreement.

We now have a Chief, not elected by Annuitants, who controls Miner-

al Council funds, even though they come entirely from minerals income. Recently when the Council wished to take a trip to D.C. to ask the BIA to oversee the upcoming Mineral Council election, he refused to release their already budgeted travel funds. They had to borrow money from their lawyer to make the trip.

The Trust Team, that directs our Trust lawsuit attorneys, includes the Chief and the Congressional

Speaker. These two officials are elected by an entirely different constituency, and are legally and morally obligated to serve the interests of that separate group. Also, our Trust lawyers say they are now working for the Osage Nation, not the annuitants, yet their costs are paid entirely with Minerals' funds.

These are but a few examples showing how the Council, and thus the Annuitants, are no longer in charge of Mineral Trust business.

As your Councilman I pledge to work with the Osage Congress to initiate Constitutional amendments that clearly state that the Mineral Council is in charge of Mineral matters. I also will work with the newly elected Chief to return all Trust control possible under the current Constitutional wording.

(revenue), but we have to do it in an intelligent way," he said citing another gaming tribe's spending and saving plan.

Retired state district judge Doug Revard is seeking a second Congressional term. He served on the Nation's government reform commission in 2003 after retiring from the courtroom before deciding a Congressional run.

"What an experience it has been," Revard said. "What did I learn from that? Well, No. 1, I learned you better have alligator skin... I think I have been a conservative voice, I believe we are spending your money every time that we do something and we should look at it in that light."

Congressman Raymond Red Corn, who is seeking a second term, listed legislation he has sponsored including the open records act, the whistleblower act, the "Speak What's on Your Mind" act and the bill creating the Osage LLC. Referring to the recent U.S. 10th Circuit Court decision ruling against

the Nation, Red Corn said there is "now more emphasis than ever on the diversification" of the Nation's non-gaming business efforts.

A second Revard rally was scheduled for March 20 in Pawhuska, but it was postponed due to snowy weather which struck Northeast Oklahoma that weekend. Ryan told the Osage News the Pawhuska rally will be rescheduled with a tentative date set for May 1.

term. His post expired at the Hun-Kah Session's end on April 15.

"I am very proud of the work we have done at the ONGC, the credibility we have earned and the successes we have achieved to the benefit of the Osage people," Chissoe wrote in his resignation letter, dated March 22. "I will remain ever grateful for being given the opportunity to return home, honor my family legacy and serve the Osage Nation."

It was unknown if Chief Gray made a second and/ or third gaming board appointments to replace Homer and Pease when this issue of the Osage News went to press. He said April 16 that Terry Mason Moore, who is the attorney representing the gaming board, would replace Chissoe as commissioner.

Moore, Oberly and the other gaming board members selected by Chief Gray will be subject to confirmation by the Congress.

Three Osages selected for the Nation's Editorial Board

Two college professors and Washington Post night editor to oversee, advise the Osage News

The Osage Nation Congress confirmed Denny McAuliffe, a Washington Post night editor, for the Nation's Editorial Board which oversees the Osage News during the 2010 Hun-Kah Session's final day.

McAuliffe, Osage, and a former University of Montana journalism

wspa- year, was confirmed April 15 with il last a 7-6 vote after Assistant Chief John Red Eagle broke the 6-6 tie

with a "yes" vote.

Principal Chief Jim Gray appointed McAuliffe to the Editorial Board after the Congress selected University of Illinois Professor Robert Warrior (Osage) for the board in February. McAuliffe and Warrior have selected University of Nebraska-Omaha Professor Teresa Trumbly Lamsam (Osage), who has a journalism background, as the third Editorial Board member.

The Editorial Board is being established according to the Nation's Independent Press Act of 2008 which was put into effect following last year's Supreme Court decision regarding the bill sponsored by ON Congresswoman Faren Revard Anderson. Under the bill, the Congress selects one board member, the principal chief selects the second member and the chosen two board members choose the third.

Congressman Raymond Red Corn motioned that Congress confirm McAuliffe to the Editorial Board during the April 15 session. Before the vote, Anderson voiced concerns about McAuliffe in explaining why she will not vote for him

"One of the concerns I have about Mr. McAuliffe is that the chief appointed an Editorial Council and

there were three members on that council and what happened during the time and leadership of that council is Mr. McAuliffe removed one of the members of that board and there wasn't cause," Anderson said. "There wasn't much publicized about that, there wasn't any information we could find on why that occurred and yet we find that we are in a position that this name has been put back before us."

"What I think is that a board of this sort should be a very ethical board and should have very high standards," Anderson said. "A second concern I have about Mr. McAuliffe is in his first term on the Editorial Council that there were times when an editor was needed and he paid himself as a board member to perform editorial duties. That concerns me and because of that, I will be voting 'no' today."

After no other Congress members spoke regarding McAuliffe's appointment, a roll call vote was conducted. Congress members Jerri Jean Branstetter, Doug Revard, Anthony Shackelford, Mark Simms, William "Kugee" Supernaw and Anderson voted "no" to confirm McAuliffe.

Congress members Edwards, Mark Freeman, Debra Atterberry, Red Corn, Eddy Red Eagle, Archie Mason voted for McAuliffe's confirmation with Assistant Chief Red Eagle's tie-breaking "yes" vote.

"Denny McAuliffe is as ethical a journalist as one could ever meet and is held in very high regard among Native and non-Native journalists everywhere," said Osage News Interim Editor Shannon Shaw. "The Osage News is extremely lucky to have someone of his caliber willing to donate his

free time to develop policies for our news organization."

Lamsam also served on the 2009 Editorial Council with McAuliffe and former Arkansas Democrat-Gazette reporter Tara McLain Manthey who is communications director of Arkansas Advocates for Children & Families in Little Rock.

The Editorial Council is the three-person entity set up by Chief Gray last May to oversee the newspaper after the Congressional Committee on Government Operations declined to vote on a 2009 free press bill sponsored by Congresswoman Shannon Edwards.

On April 2, 2009, the six Congress members on that committee voted 3-2 (with Archie Mason abstaining) to table the bill, pending a decision on the Osage Nation Supreme Court's first ever case involving Anderson's 2008 bill, which came in December after the three high court justices heard the case on Aug. 19.

The Supreme Court ruled against the Executive Branch ruling that Chief Gray had no cause to bring the initial suit and as a result there was no injured party. Anderson's bill stands as a result of the ruling, leading to this year's Editorial Board appointments.

Lamsam's journalism experience includes working at the Lubbock Avalanche Journal in Texas and as editor of the Osage Nation News. She is now an associate professor at UNO's School of Communications where her research interests include Native American journalism.

Warrior, director of American Indian Studies at the University of Illinois at Urbana-Champaign, was selected and confirmed by Congress during its Feb. 10 Special Session. Both he and Lamsam were interviewed by a congressional committee that day after Congress members suggested both for the governing body's board appointment.

Warrior has written several books including Like a Hurricane: The Indian Movement from Alcatraz to Wounded Knee with Comanche scholar Paul Chaat Smith, which focuses on Native American politics and protests during the 1960s and 1970s and articles for newspapers including News from Indian Country and scholarly journals.

McAuliffe returned to the Post in October 2009 to be an overnight news editor. He previously worked at the Post for 16 years before moving to the University of Montana where he taught journalism since 1999.

While in Montana, McAuliffe created and directed the Reznet journalism training program which hires Native American journalism students to be print and multimedia reporters. The students then use their experience and mentoring by professional editors to get internships and jobs at news media outlets.

a very good working knowledge of our organizational structure. I have been through three elections and two governmental changes during that time which has allowed me the opportunity to work with a diverse group of tribal leaders. I have seen first hand the positive and negative affects tribal leaders decisions can have on the operations of the Nation's government and morale of its employees and citizens. If elected I will be faced with making tough decisions affecting our Nation and I feel I can draw on my past experiences to make fair and educated decisions for the betterment of the majority of the citizenry.

I have seen our Nation grow tremendously over the past 15 years due in large part to our gaming enterprises. This additional revenue stream has allowed the Nation to provide services to our people that were not available five years ago. Although this has been beneficial to our tribal members it is important that we continue to diversify our revenue generating capabilities beyond gaming. If elected I will work with my fellow Congressional members and the Executive branch to ensure the Nation's economic future is not dependent entirely on gaming. However, I do believe we have enormous potential for growth in our gaming operations and we must be willing to explore the options before us.

The Nation currently has numerous programs both federally and tribally funded which benefit our citizenry on many different levels. If elected I will work to continue to improve and expand the services we offer to our members.

Finally I am a shareholder as are many members of my family. Our leaders have a duty to protect the minerals estate; and if elected I will continue to support the protection of the shareholders interests.

This Nation has been good to me over the past 15 years and for that I am grateful. I feel my education and experience in working for this tribe will enable me to serve our people well. I will listen, be fair and do my best to make educated decisions. I would appreciate your vote this June. God Bless.

Osage LLC partners with three companies for business relationships

ON Congress passes appropriation bill to give the LLC a \$7.5 million capital contribution during Hun-Kah Session

The Osage Limited Liability Company is partnering with three separate companies for business relationships, one of which could bring 30 jobs if a company distribution plant sets up shop at the Tulsa Airpark.

The LLC has made a passive investment with Kansas-based Duraseal Pipe Coatings Company which uses nanotechnology to make pipe coating for pipelines which carry resources such as oil and natural gas. As part of the passive investment, the LLC is inviting Duraseal to open a distribution center at the Osage Nation-owned Tulsa Airpark, which could bring more job opportunities for the Nation, LLC CEO Carol Leese said.

If the distribution plant comes to the Airpark, it would create about 30 jobs, Leese said. The distribution plant would employ engineers, mid-level management and unskilled labor jobs, he said.

Nanotechnology is used by Duraseal, based in Olathe, to make DuraSil Nano Penetration Coating, according to the company's Web site. The company makes the protective coating so the treated pipes can withstand conditions such as corrosion, high-abrasive atmospheres and extreme temperatures.

"They help pipes last longer in the oil and gas industry and exchanging pipes (due to wear and tear) in an oil well is very expensive," Leese said of Duraseal's industry efforts. "Not only does it save money on pipe, but it also prevents pipes from getting shut down" for maintenance, he added.

Leese said the Tulsa Airpark is "a good geographical location" for a Duraseal distribution plant because it's an easier spot to transport the pipes to and from the plant. A timeline on the plant is unknown.

"We're going through the numbers of cost," Leese said before the LLC met with the Congressional Commerce and Economic Development Committee on April 8 to provide the Congress members an update on its operations and review of its 2010 operating plan.

ON Congress passes bill to give the LLC a \$7.5 million capital contribution

In a recent development, the Osage Nation Congress approved ONCA 09-77, sponsored by Congressman Raymond Red Corn, which is an appropriation bill to give the LLC a capital contribution of \$7.5 million.

The bill passed with a 9-2 vote on April 14 – one day before the 2010Hun-Kah session concluded. Voting against the bill were Congressmen Doug Revard and William "Kugee" Supernaw while Faren Revard Anderson was absent during the vote.

"I take this podium for one of the last times and I ask again for us to be conservative," said Revard who is not seeking re-election in June. "We are at a stage with the federal lawsuit that we are not certain whether our main industry - the Million Dollar Elm (casinos) – will the LLC passes on the opportunity, be operating as we know it today," he said of the federal lawsuit against the Oklahoma Tax Commission.

Congressman Mark Simms said "the LLC is ready to acquire other companies and to go forward. This is a time to not to be conservative, this is a time to diversify... we cannot always depend always on the gaming" in urging the Congress to support the contribution.

The Congress also confirmed LLC Board Member Paul Bruce with a unanimous vote on April 15 before it adjourned the Hun-Kah Session.

Other LLC agreements with businesses

The LLC has entered into a jointpartnership with a Florida-based investment banking firm to establish a minority broker dealer which will hear some of the various business deals proposed to the Osage LLC each year, many of which are turned down.

The LLC is joining forces with National Holdings Corp. to create the minority broker dealer, which will be named Osage Capital, Leese said. He added the LLC has seen hundreds of pitched business deals in its past initial year of operation, with the majority turned down because they don't fit the LLC's strategy

"As an LLC, we see thousands of deals, we see them everyday," said Leese. There's only some, a very few that fit our strategy... this gives us the opportunity to monetize our deal flow."

For example: If someone wants to pitch a proposal to the LLC so he/she can raise \$50 million but the LLC will refer that person to Osage Capital and if Osage Capital helps that person raise the \$50 million, Osage Capital will collect a fee from that person, Leese said.

"I've been looking at this strategy for a few years because no one's doing it in Indian Country," Leese said. "It really gives the opportunity to mesh Wall Street with Indian Country and it's very progressive."

The LLC has also signed a joint venture with the Manhattan Construction Company to go after construction projects focused on government contracting, Leese said.

"Our goal is to go after government contracts and also tribal business opportunities and commercial business," Leese said. "There is a lot of stimulus money out there. This enables us to be a player."

Leese said the LLC will also be a co-sponsor of the upcoming Native American Contractors Association workshops on the Native 8(a) program. It is slated for April 19-20 in Tulsa.

Osage gymnast competes for state, national titles

Jaelyn Olsen trains with Osage gymnastics coach in Oklahoma City, focusing on scholarship

BARTLESVILLE, Okla. – Jaelyn Olsen started competing in gymnastics when she was five and met another Osage gymnast who's helped her along the way as a coach. Now she competes as a Level 10 gymnast in gymnastics events nationwide.

"I saw it on TV and said I want to do it, I like to tumble," the 15-yearold Osage said of her first interest in gymnastics. Jaelyn, 15, who attends Putnam City West High School in Oklahoma City, works with Jeff Carter and his wife Trish Carter, who are both coaches and owners of Mat Trotters Gymnastics Center also in Oklahoma City.

"She's a hard worker, knows what it takes," Jeff Carter said of Jaelyn while they attended last month's USA Gymnastics Okla-

homa State Sectional Meet where Jaelyn and several other Mat Trotters gymnasts performed. "She's only a sophomore and a lot of college coaches are looking at her. Our focus right now is to get a scholarship with her talent," said Carter who grew up in Pawhuska.

Jaelyn performed on the uneven bars and balance beam at the event in Bartlesville while recovering from a sprained ankle injury. She didn't compete during the floor and vault events to avoid aggravating the injury and left the competition with three medals for her performances.

Her father, Biff Olsen, says their home has "hundreds of medals accumulated over the years" from Jaelyn's competitions. "There's probably no other sport that puts in hours as gymnasts do."

Jaelyn spends four hours a day, five days a week practicing gymnastics. "There's never really an off-season," Carter said. "Training still takes place in the summer, the sport's always changing and skills can get bigger and better."

Carter and his wife Trish Carter

started gymnastics during child-hood, both attended OU where they met in 1986 and have won several honors for gymnastics. They have been married since 1990 and have a daughter named Carley.

Jeff Carter competed at the state, region and national levels from 1981-1987. He was an All-State gymnast from 1983 to 1986 and received the Outstanding Gymnast Award in 1986.

Trish Carter is from Puerto Rico and came to OU in 1986 after attending Oklahoma State University, which dropped its gymnastics program that year.

The Carters have been coaching at Mat Trotters since 1992 and became the gym's owners in 2001.

Jaelyn finds bars to be the most challenging of the four gymnastics events. "Physically it's the hardest event," she said adding gymnastics is the only sport she trains in.

Jaelyn's parents know it takes a lot of training and practice to compete in sports. Her mother, Mary Olsen, played basketball while she attended the University of Oklahoma and Biff Olsen wrestled during high school.

Mary Olsen says it takes hours to practice for a major gymnastics event that has eight minutes of competing time for gymnasts. Each of the four gymnastic events has two minutes of performing time for each gymnast.

"They're judged on everything before they even hit the ground," Mary Olsen said of the gymnasts. In the all-around floor exercises, "the girls have to be in sync with the music" played during the performance, she said.

When she's not practicing at the gym or performing at gymnastics competitions, Olsen enjoys attending OU sporting events and dancing at powwows. At school, she maintains a 3.6 grade-point-average and enjoys English because she likes to read.

Jaelyn's resume includes several awards including honors for State All-Around Champion for: Level 4 in 2002; Level 5 in 2003; Level 7 in 2004; and she was the Level 8 State Champion in 2005. In 2008 she was a Level 10 Junior Olympics Nationals Alternate and won at the JO Regional Qualifier that year.

Amid her sprained ankle injury, Jaelyn competed again at the Junior Olympics Regional competition in Albuquerque, N.M. earlier this month, but did not advance to the National competition.

Jaelyn placed 11th out of 25 and was two spots behind the top nine who will compete at the National competition, Biff Olson said after the Albuquerque competition.

"We're going to let her heal up now and get ready to go down to the World of Gymnastics" in Texas, he said. Jaelyn will head to Plano to perform at a two-day collegebound workshop in June, which will have college coaches watching the athletes, he said.

Osage language students at Pawhuska High School win third place for film shown at Native American Youth Language Fair

NORMAN, Okla. — Osage language instructor Talee Red Corn's class at Pawhuska High School earned third place on April 6 at the Oklahoma Native American Youth Language Fair for their video entry which parodied the 1992 film "Wayne's World" while incorporating the Osage language into the plot.

The nine-minute student film titled "Osage Awakening" included several English-language rock songs for its background and featured several special camera effects used by the fictional characters "Wayne" and "Garth" in their 1990s-era comedy and film skits. Despite these modern-day influences, the students used the Osage language and culture in the plot.

The film is about "an Osage who didn't want to learn Osage (language)," Red Corn said. The main

male star fell in love with an Osage girl, ends up learning the language and "he goes off and likes it," he said.

The film started out as a class project, but eventually became an entry for the language fair now in its eighth year on the University of Oklahoma campus. The event, held at OU's Sam Noble Oklahoma Museum of Natural History on April 5-6, invites school-age students (from pre-school to high school ages) to use their creativity and language knowledge to participate in the language fair activities.

The language fair welcomes students to enter categories such as spoken language, language with music/ dance, language with PowerPoint and art posters to showcase their ancestors' language skills.

This year's events for high school-aged students were held on April 6 when Red Corn's class took third for their video entry. Also



The Osage Language Department offers classes in Pawhuska, Fairfax, Hominy, Skiatook and Edmond.



Portrait of Chief Gray unveiled, on display in Osage Tribal Museum

Osage artist R.A. Red Corn and Osage Tribal Museum officials unveiled a portrait she painted of Osage Nation Principal Chief Jim Gray during a March 31 museum event celebrating the occasion.

The color portrait shows Gray standing wearing a suit, bola tie and holding an eagle fan. To his right is a dark wood-finished desk with a copy of the Osage Constitution standing on top. His portrait joins other paintings of past Osage chiefs in the museum.

"I'm really very humbled about this entire gesture," said Gray who later added he has "enormous respect for those chiefs who have served in the past."

Gray was first elected chief in

2002 under the tribe's former government structure and was re-elected in 2006 when the government was reformed and the 31st Tribal Council adjourned for the First Osage Nation Congress to take its place as a governing body.

Gray, who is running for a third term, said he is most proud of seeing the new government's Constitution take effect during his term.

"As a preacher of our governing document, the reason I asked (Red Corn) to put (the Constitution) in there is because for better or worse, for good or ill, I think the only thing that I can say I am most proud of was having this Constitution done," Gray said. "That

Last day of the Hun-Kah Session brings leadership changes, honors for outgoing Congress members

The First Osage Nation Congress gathered for its final regular session April 15, which ended with a laundry list of actions and leadership changes after its members voted on the motions which include selecting a new Speaker, Second Speaker and honoring the six Congress members whose terms expire after the June election.

Congresswoman Shannon Edwards introduced ONCR 10-17 in which she acknowledged the six Congressional members whose terms are nearing an end.

"It's a resolution commending Congressmen [Mark] Freeman, [Raymond] Red Corn, [Doug] Revard and [William "Kugee"] Supernaw, and Congresswomen [Faren] Anderson and [Debra] Atterberry for their leadership in and service to the Osage Nation Congress for the betterment of the Nation," she said before making a motion to fast track the resolution onto second reading, which didn't have everyone's vote after the resolution was successfully fast tracked for a final floor vote.

Revard and Anderson abstained from voting while the 10 other Congress members passed ONCR 10-17. Red Corn and Supernaw are seeking re-election in June while the other four members with expiring terms are not.

Edwards presented each of the six Congress members with the citations honoring their four years of service and a handshake. "Pictures later." she said.

Later, Congresswoman Jerri Jean Branstetter motioned for the Congress to select its new Speaker and Second Speaker positions after the 12 members rescinded their secret ballot confirmation votes from April 7 and April 9 for five boards and voted on each board member appointee publicly. These public votes resulted in dismissals of George Pease and Elizabeth Lohah Homer from the Gaming Enterprise Board.

Congress, which has previously conducted its annual election for the Speaker by secret ballot as written in the Congressional rules, suspended the rules and voted openly on the Speaker and Second Speaker positions.

"Mr. Speaker, I nominate Congresswoman Faren Revard Anderson to the position of Speaker," Congresswoman Jerri Jean Branstetter told Archie Mason who has been Speaker since the First Congress took oath in 2006. He recent-

ly told his Congressional colleagues he would not accept another nomination as Speaker when the Hun-Kah Session ended.

Congresswoman Debra Atterberry then nominated Eddy Red Eagle for the post, who declined the nomination. She followed up by nominating Raymond Red Corn who also declined.

"I would like to hear the nominated speaker's speech as to why she feels she's qualified to be in this position," Atterberry said of Anderson's nomination.

"Thank you for the invitation," Anderson replied without elaborating. Red Corn called for a roll call vote on the speaker position after the call for nominations ceased.

Anderson became Speaker after a 7-3 vote ruled in her favor. Atterberry, Mark Freeman and Red Corn voted against Anderson's nomination. Edwards left the session before the vote was taken and Anderson abstained from voting for herself.

"It's been a good run," Mason said as he introduced Speaker Anderson and stepped away from the Speaker's elevated post. Anderson and Mason switched seats while the Congress members and attendees applauded.

"The floor's open for nominations for Second Speaker," Anderson said. "I'd like to nominate Jerri Jean Branstetter as Second Speaker," Simms said.

Branstetter, who also abstained from voting for herself, received 10 unanimous votes.

Just before the Hun-Kah Session concluded, Congressman Shackelford was elected to the Congressional Affairs Committee after Second Speaker Branstetter became that committee's chairwoman.

Anderson said she did not seek the position of Speaker but accepted the position because she "was the only nomination." Anderson has been nominated at the end of every congressional session and until now has always lost to Archie Mason. Mason told the Osage News he would not be seeking the Speaker position.

Anderson will now sit on the Osage Nation Trust Team for two months in which she said she will be "participating and informing the congressional members of the trust case progress."

Mark Freeman Jr., 89, is a successful Osage County rancher and businessman, and has lived on the reservation since the end of his service as a Marine Corps arial navigator and pilot in World War II. Freeman was elected to the Osage Tribal Council in 2002, and was instrumental in the drafting and promotion of P.L. 108-431, which resulted in one person, one vote for citizens of the Osage Nation.

In 2006 he signed on as a candidate for the newly formed Osage Nation Congress, becoming the only member of the old Council to be elected to the new legislature. Mr. Freeman will retire from public service when the 1st Congress adjourns this spring.

I was the property committee chairman that built the senior housing on campus and the Title VI facility to serve our elders. As councilman I worked on the coal bed methane leases that were first in our nation during the hardest of times in the Osage mineral estate.

In the roads program alone I directed our multi-million dollar roads and bridge construction in our reservation and reached national recognition by the office of Intertribal Transportation Association Presidency for two terms and completing two federal national town hall meetings for all of Indian country. The Osage Nation has lawsuits that will have everlasting effects on our people and the administration has not secured the monies to the people just to the attorneys.

The reservation is under siege by the State of Oklahoma and numerous other innuities to dissolve the mineral estate and our future.

I will work for the protection of the minerals estate and for accountability to be restored to all federal programs and tribal operations just as I have done in the past.

We can not settle the trust case for pennies on the dollar. The Osage Nation is owed billions by the U. S. Government and the fiduciary trust irregularities, which happened on their watch. The knowledge that I have on these cases allows me to walk in to the Office of the Assistant Principal Chief and go to work.

We come from the greatest war tribe on the plains and we lasted because of leadership, dedication and viewing any war-front being as one. I will be on the forefront working on the deficiencies and the direction that the constitution allows, insuring that the freedom of the Osages will continue to grow well into the next four years and beyond.

Vanessa Moore wins Osage Tribal Princess title

The clapping, yells and lulu's as Vanessa Moore's name was called at the Osage Tribal Princess Sorority honor dance to name her as the new Osage Tribal Princess April 27 made her smile from ear to ear.

Wearing traditional Osage clothes with a sparkling black shawl, Moore walked the length of the dance arena to a standing ovation to accept her new title. She received a bouquet of red and pink roses, a gift bag and a chance to represent the Nation starting this summer. Moore will be crowned in July after the current princesses, Erica and Elizabeth Moore, give up their title.

She is the winner of the first inaugural OTP pageant where, also for the first time, Osage tribal members voted individually for their favorite candidate. Tribal members had three venues to vote for their favorite candidate with most voting at the OTPS honor dance that evening. Annawake Varley, first runner up and the only other contestant in the pageant, will fill in for Moore if she is unable to fulfill her duties as princess.

Joining a long list of women that began with the now deceased Margaret Luttrell Gray, who was the first OTPS in 1941, Moore will begin her duties at the American Indian Exposition Fair in Anadarko, Okla. Also known as the Indian Fair, she will spend a week attending banquets, talent demonstrations and other princess activities hosted by the fair's committee and other tribal princesses in attendance.

Moore, 19, is a freshman at Northeastern State University where she maintains a 4.0 grade point average and belongs to NSU's Native American Student Association, the Indian University Schol-

ars Society, the American Indian Science and Engineering Society and the American Indian Business Leaders.

Moore is from the Hominy District and participates in all three districts In-Lon-Schka dances and has all her life. She fingerweaves and teaches others how to learn the craft. For the traditional and contemporary talent event, Moore showed the audience what it takes to learn how to fingerweave and also showed the first belt she made on her own.

"Sometimes when I'm in my dorm room at school and I'm missing home, I just take out a belt I'm working on and it helps me feel like I'm at home," she said. "I'm very proud of my belt, it was the first one I ever made."

As well as fingerweaving, she makes Osage shirts, peyote stitches on broadcloth and is currently learning how to do Osage ribbonwork and how to make moccasins. She attends powwows around the state when she gets the chance and she is a student of the Osage language. At 2008's annual Youth Language Fair in Norman she took home honorable mention for best t-shirt design where she incorporated the Osage language into art.

"Deep within each Osage word spoken, each bead placed and each wool skirt tied on, there is a meaning. A meaning known to only minds that meet. When the mind meets with the other, there is a spiritual and insightful bond," Moore wrote in an essay on what makes her a traditional Osage girl. "The understanding and meaning of each motion put forth into any action and the moment of epiphany occurs is what makes a person traditional. I wholly know that is what makes me a traditional Osage girl."

Vanessa Moore is the daughter of Michael and Hazel Pratt Moore of Hominy. Her maternal grandparents are the late Edward Norris and Frieda Kipp Pratt; paternal grandparents are Wilson and Virginia Moore of Pawnee; maternal great granddaughter of Josephine Wah-Re-She and George Kipp.

THPO honored by the Missouri Archaeology Society

On March 20, 2010, Dr. Andrea A. Hunter, Tribal Historic Preservation Officer and director of the Historic Preservation Office, was awarded the 75th Anniversary Achievement Award by the Missouri Archaeological Society. The Missouri Archaeological Society is a nonprofit organization dedicated to archaeological education, research, and preservation.

This honor is awarded to the "individual who best exemplifies the ideals of the Society and whose continuing contributions to Missouri archaeology demonstrate the highest order of achievement."

Dr. Hunter was selected for this award for her courageous efforts to preserve Sugarloaf Mound, which was purchased by the Osage Nation in July of 2009. Sugarloaf Mound, the last remaining mound in the St. Louis Mound Complex, was built by ancestors of the Osage. This reestablishment of geographic ties between the Osage Nation and the state of Missouri will provide rich cultural and educational opportunities, which are currently in the development stages.

Osage Nation hosts Tribal Sex Offender Registry Training

By now, many of you have at least seen the groundbreaking television show America's Most Wanted. The host of that series is John Walsh and in 1981 John's six-year-old son, Adam was abducted from a shopping mall and murdered. As a result of that tragedy, John Walsh dedicated his life to apprehending fugitives, advocating for laws to protect children from sexual predators and was the driving force behind the "Adam Walsh Child and Protection Safety Act". This Act was signed into law by President George Bush in 2006 and requires all jurisdictions to strengthen their monitoring and tracking of sex offenders.

In July 2007, the Osage Nation Congress passed resolution ONCR 07-12 sponsored by Congressman Doug Revard and co-sponsored by Congresswoman Debra Atterberry. Electing to participate as a registration jurisdiction, the goal is for the Osage Nation to develop and manage its own tribal sex offender registry and to protect tribal citizens from these types of offenses. In September 2009, the Department of Justice (DOJ) awarded the Nation with an Adam Walsh Implementation grant to get the project up and running.

Since this time, the Osage Nation Adam Walsh working group formed, holds monthly meetings and has been busy trying to understand implementation issues and how it

will fit into day to day operating processes of the Nation. The working group consists of members from several Osage departments such as tribal police, social services, courts, prevention, counseling, IT, strategic planning and works with American Indian Development Associates of Albuquerque N.M. Some members of the working group met with the Kickapoo Tribe to understand how they developed their registry and what issues they encountered. The deputy attorney general of the Chickasaw Nation attended the November monthly meeting to discuss their issues as well.

On March 23, 2010 the Osage Nation's Office of Strategic Planning hosted a half day Question/Answer session with the DOJ's Office of Sex Offender Sentencing, Monitoring, Apprehending, Registry and Tracking (SMART). The working group, some members of Congress and the Executive office were given an opportunity to have any concerns addressed with the law and ask questions about the implementation project. This was followed by a full day of training on the web-based software known as TTSORS, which stands for Tribe and Territory Sex Offender Registry System. The Osage Nation extended the training invitation to several other jurisdictions with over 40 participants. Representatives from tribes in Oklahoma, Iowa, and Washington State were in attendance.



ON Women, Infants and Children program awarded breastfeeding grant

ON WIC program only Oklahoma agency to receive grant

The Osage Nation Women, Infants and Children program was awarded a \$5,059 grant for its breastfeeding performance March 31. The Agriculture Secretary Tom Vilsack announced performance awards to states that have done an exceptional job promoting and supporting breastfeeding efforts among mothers participating in the Special Supplemental Nutrition for Women, Infants, and Children (WIC).

The bonus awards were divided among the top ten state agencies with the highest rates of breastfed infants and the greatest improvement in breastfeeding rates.

Each award is based on the state agency's proportionate share of breastfeeding. WIC participants are eligible for a minimum award of \$5,000 for small state agencies and \$50,000 for large state agen-

historically promotes breastfeeding as the optimal method of feeding infants, unless medically contraindicated, as it provides positive health benefits for both the mother and child.

The new structure replaces the current structure which bottlenecks at the Director level with 38 Directors reporting to one Director of Operations, which is unworkable and inadequate by any standard. The newly proposed structure adds Division Leaders, who would supervise and support Directors with a 5-to-1 ratio, which is more realistic and provides proper oversight plus mentoring opportunities. I believe we must invest in our employees and our Osage people. I have


